3 AN ORDINANCE OF THE CITY COMMISSION OF THE
4 CITY OF OAKLAND PARK, FLORIDA, UPDATING THE
5 CITY'S 2007 COMPREHENSIVE PLAN TO PROVIDE FOR
6 THE 2017 ANNUAL UPDATE TO THE CAPITAL
7 IMPROVEMENTS ELEMENT BY UPDATING THE TABLES
8 AND SCHEDULES OF SECTION 9 "CAPITAL
9 IMPROVEMENTS ELEMENT" IN RELATION TO CHAPTER
10 163, PART II, FLORIDA STATUTES; PROVIDING FOR
11 SEVERABILITY; PROVIDING FOR CONFLICTS; AND
12 PROVIDING FOR AN EFFECTIVE DATE.

14 **WHEREAS**, the City of Oakland Park, Florida proposes the 2017 annual
15 update of the tables and schedules of Section 9. “Capital Improvements Element” of
16 the City’s 2007 Comprehensive Plan; and

18 **WHEREAS**, the Engineering and Community Development Department of the
19 City recommends that the City Commission update the tables and schedules of Section
20 9 “Capital Improvements Element” of the City’s 2007 Comprehensive Plan; and

22 **WHEREAS**, a public hearing was held by the City commission of the City of
23 Oakland Park to allow for public participation in relation to the preparation and review
24 of the proposed updates to the 2007 Comprehensive Plan; and

26 **WHEREAS**, the City Commission of the City of Oakland Park, Florida, held a
27 public hearing on February 1, 2017, pursuant to Chapter 163 of the Florida Statutes, at
28 which time the parties and interests and all other citizens and residents of Oakland Park
29 so desiring to participate had an opportunity to be and were heard; and

31 **WHEREAS**, the City Commission of the City of Oakland Park, Florida has
32 determined that the public has adequately participated in the planning process as
33 required by Chapter 163 of the Florida Statutes during the course of the preparation;
34 and

36 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION
37 OF THE CITY OF OAKLAND PARK, FLORIDA, THAT:

39 **Section 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed
40 as being true and correct and are hereby made a part of this Ordinance.

Section 2. The City Commission of the City of Oakland Park, Florida hereby approves and adopts the proposed 2017 annual update to the Capital Improvements Plan by updating the tables and schedules of Section 9 “Capital Improvements

1 Element” of the City’s 2007 Comprehensive Plan. The proposed tables and schedules
2 are attached hereto and identified as exhibit “A”, as amended.
3

4 **Section 3.** If any clause, section or other part of this Ordinance shall be held by
5 any Court of competent jurisdiction to be unconstitutional or invalid, such
6 unconstitutional or invalid part shall be considered as eliminated and in no way
7 affecting the validity of the other provisions of this Ordinance.
8

9 **Section 4.** All Ordinances or parts of Ordinances in conflict herewith are
10 hereby repealed to the extent of such conflicts.
11

12 **Section 5.** This Ordinance shall be effective upon its passage and adoption by
13 the City Commission of the City of Oakland Park.
