ORDINANCE NO. O-2007-021

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, AMENDING THE CODE OF ORDINANCES, BY SPECIFICALLY AMENDING CHAPTER TWO ENTITLED "ADMINISTRATION"; PROVIDING FOR AN AMENDMENT OF SECTION 2.72 TO PROVIDE FOR A UNIFORM ATTENDANCE POLICY FOR ALL CITY BOARDS NOTWITHSTANDING ANY PROVISIONS SET FORTH IN THE CODE OF ORDINANCES PREVIOUSLY ADOPTED BY THE CITY COMMISSION; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Oakland Park has determined that it is in the best interest of the citizens and residents of the City to provide a uniform attendance policy for all City Boards;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA THAT:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Ordinance.

Section 2. The City Commission hereby amends the Code of Ordinance, by specifically amending Chapter Two entitled "Administration" Section 2.72 to read as follows:

Attendance Policy. If any member is absent from four (4) meetings during a twelve-month period, with or without advance notice to the board secretary acting as the liaison to the City Commission via the City Clerk's office, approval of the City Commission, the member's position shall be referred to the City Commission for review and consideration of vacating the position at the meeting following the 4th absence. The Commissioners will be provided attendance records, including all documentation related to absences, managed by the board secretary when considering whether to retain the board member or appoint a new member. Notwithstanding any provision to the contrary, this section shall supersede all provisions in the code relative to attendance at all Board meetings.

1 **Section 3.** This Ordinance shall apply to all City Boards including the
2 Beautification Advisory Board, Board of Adjustment, Civil Service Board, Code
3 Enforcement Board, General Employees' Pension Board, Planning and Zoning Board,
4 School Advisory Board, and Unsafe Structures Board.
5

6 **Section 4.** It is the intent of the City Commission that this attendance policy shall
7 prevail and be considered superior to any contrary language in the Code of Ordinance.
8

9 **Section 5.** If any section, subsection, sentence, clause, or provision of this
10 Ordinance is held invalid, the remainder of this Ordinance shall not be affected by such
11 invalidity.
12

13 **Section 6.** That all Ordinances or parts of Ordinances and all resolutions or
14 parts of Resolutions in conflict with this Ordinance are repealed to the extent of such
15 conflict.
16

17 **Section 7.** It is the intention of the City Commission of the City of Oakland
18 Park, that the provisions of this Ordinance shall become and be made a part of the Code of
19 Ordinances of the City of Oakland Park, Florida, and that the Sections of this ordinance may
20 be renumbered, re-lettered and the word "Ordinance" may be changed to "Section,"
21 "Article," or such other word or phrase in order to accomplish such intention.


23 **Section 8.** This Ordinance shall be effective upon its passage and adoption by




