	32	City Commission, the member's position shall be referred to the City Commission
	33	for review and consideration of vacating the position at the meeting following the
	34	4 th absence. The Commissioners will be provided attendance records, including
	35	all documentation related to absences, managed by the board secretary when
	36	considering whether to retain the board member or appoint a new member.
	37	Notwithstanding any provision to the contrary, this section shall supersede all
	38	provisions in the code relative to attendance at all Board meetings.
