The regular meeting of the City Commission of the City of Oakland Park, Florida was called to order at 6:30 p.m. by Mayor Lonergan.

A moment of silence was followed by the Pledge to the Flag. American Legion Post 222 Commander Mark Reynolds, Second Vice Commander Eugene Anderson, and District and State Chaplain Steve Newman Post led the pledge to the Flag.

Presentations

A. MAYOR LONERGAN - STATE OF THE CITY ADDRESS

Mayor Lonergan delivered the State of the City address, stressing how positive the last year had been for residents and businesses. He thanked the Volunteer Group of the Year: the Kiwanis Club of Oakland Park; the Business Partner of the Year: Home Depot; the Youth Volunteer of the Year: Carla Siberian, and Volunteer of the Year Pat Crowley for their dedication to the City. He also expressed gratitude to the Oakland Park/Wilton Manors Rotary Club, the Oakland Park Business Group, the Oakland Park Garden Club, Friends of the Ethel M. Gordon Oakland Park Library, and all the other groups that provided services to the city.

Charles Livio, City Horticulturist, provided a brief overview and Commissioner Guevrekian presented the award to Felix Fidelibus at 618 NE 38 Street.

* LOCAL GOVERNMENT ACADEMY 2017

Heidi Burnett, Director of Parks and Leisure Services, provided a presentation that included highlights from the 2016 Local Government Academy class. Mayor Lonergan asked that two students from Northeast High School's civics class be included in the academy in the future.

2. REQUEST FOR DESIGNATION OF THE PROPERTY AT 3501 NW 31ST AVENUE AS A "GREEN REUSE AREA" PURSUANT TO SECTION 376.80(2)(C), FLORIDA STATUTES, BY OAKLAND PARCEL, LLC. ADVERTISING FOR THIS PUBLIC HEARING APPEARED IN THE SUN-SENTINEL SEPTEMBER 14, 2016. THIS ITEM WAS TABLED AT THE SEPTEMBER 21, 2016, CITY COMMISSION MEETING TO A DATE CERTAIN OF NOVEMBER 2, 2016.

City Attorney Doody explained there would be two resolutions related to this request: one is regarding the designation and one regarding conditions for development, mentioned in supplemental agenda. The city attorney swore in the witnesses and the quasi-judicial public hearing was held.

Kristin Nowicki, Senior Planner, provided a presentation.

Michael Goldstein, attorney for Cornerstone Group, the owner and developer, thanked the commission and city staff for working with them on the request.

Joe Weiselberg, Cornerstone Group, owners of subject property stated to agree to all terms and conditions in the covenants.

The public hearing was held as advertised.

Cheryl Dickey - 3299 Unit 5, NW 44 Street - She was pleased with project and the outreach initiative. She suggested the commission consider additional outreach requirements in the future,

such as door hangers and flyers. People in the area of this development should be informed about the fact that there was nothing hazardous going on at the development site.

Jeff Helyer - 740 Park Lane West - He said he had attended the informational meeting and supported the project.

Mitchell Stollberg-Appleyard - 60 NW 47 Street - He said he was in favor of the project. He requested additional food stores be developed on the west side of the city.

Mr. Goldstein stated they had reached out to City of Lauderdale Lakes pursuant to the commission's wishes.

Commissioners disclosed communications they had with the respondent's representatives.

David Vanlandingham, P.E. Senior Environmental Engineer at Broward County discussed how airborne contaminants were handled during development and how the county enforced air quality codes.

City Manager Hebert confirmed the code enforcement liens had been resolved through the city's lien resolution policy.

City Attorney Doody swore in the witnesses.

Broward County Sheriff's Office Detective Eric Blevins testified that on October 11, 2016, he had visited Pure Platinum at 10:38 P.M. and seen approximately 75 patrons, the majority of whom appeared to be consuming alcoholic beverages while entertainers were performing partially or fully naked. This was a violation of city ordinance 7-147 and he had filed a report.

Based on the testimony, City Attorney Doody asked the commission to consider revocation or suspension of the nightclub's Open Past Midnight Permit until such time as the property was brought into compliance.

C. Edward McGee Jr., attorney representing Cornell Business Ventures, the land owner, stated "legally, factually and pragmatically" the commission should deny the recommendation, stating the owner did not accept the validity of the city ordinance under which they had been cited. He explained that in 1987 there had been a final judgement entered against the City if Oakland Park awarding a permanent injunction against the enforcement of the adult entertainment ordinance that had been passed. He said the judgement permanently enjoined the city against enforcing any ordinance enacted thereafter. Mr. McGee indicated that the non-conforming use was not subject to subsequently adopted ordinances.

Mr. McGee said there were appeals and motions to stay pending in state and federal courts regarding a judge's ruling against Cornell concerning the city zoning violation. He asked the city to await the results of the appeals.

City Attorney DJ Doody stated the fact was the business was violating the ordinance and Mr. McGee's presentation admitted it. He added that Judge Kahn had opined that the city was not enjoined from enforcing its licensing regulations; the regulations passed in 2004 were enforceable.

The public hearing was held as advertised.

City Attorney Doody explained that revocation or suspension would not force the club out of business; it would preclude them from selling alcohol after midnight.

Vice Mayor Adornato moved to suspend license until they come into compliance and otherwise that the establishment may seek a review after three months. Commissioner Shank seconded. Commissioner Shank removed his second to allow for further discussion.

Commissioner Shank moved for a three year revocation. Motion died for lack of second.

Commissioner Shank moved to suspend the permit until compliance is reached due to finding of fact that a violation exists and property is operating outside the code of ordinances. Vice Mayor Adornato seconded the motion, which prevailed by the following vote:

Shawn O'Brian - 4105 A1A, Lauderdale by the Sea - He stated his support for All Saints Catholic Church feeding program.

Mitchell Rosenwald - 1353 NE 34 Street - He was very impressed with the improvements at the Prospect Plaza; He encouraged the city commission to sit down with Father Bob at All Saints Catholic Church to reach an agreement; He thanked Mayor Lonergan for his State of the City address.

Commissioner Shank commented as follows:

- 1) He thanked Don Widing, Chief of the Fire Rescue Department, and staff for assisting a public speaker with treating an open wound earlier.
- 2) He reported he had been corresponding with a resident regarding a spike in the resident's water bill and asked staff to provide the correspondence to the city commission so the issue could be resolved.
- 3) He remarked how well Mayor Lonergan had conducted himself as Mayor, particularly at this evening's meeting.
- 4) He felt it was a shame that the city's mayoral term lasted only one year and suggested the next commission consider a 4-year elected mayor.
- 5) He said it had been a pleasure and an honor to serve the community and to work with city staff. He indicated he had gained much during his tenure on the commission. He thanked the community and stated he would always be available.

Commissioner Carn commented as follows:

- 1) He said he had enjoyed serving with Commissioner Shank and appreciated his sacrifices.

- 5) He had been contacted by a concerned resident about prostitution in massage parlors in the city.
- 6) He thanked Mr. Stollberg-Appleyard for informing them about the graffiti app.
- 7) He encouraged everyone to recycle.
- 8) He hoped that all incumbent candidates to return to the commission after the election.

Commissioner Guevrekian had no comments.

Vice Mayor Adornato commented as follows:

- 1) He remarked on the amazing number of ribbon cuttings taking place this week and said the Prospect Plaza event was a milestone.
- 2) He attended the Broward Mayors' Gala and thanked staff for their efforts.
- 3) He reported the Trunk or Treat event had been spectacular. He said staff was doing a great job celebrating the community.
- 4) He thanked Charles Livio, City Horticulturist, for all his efforts while working at the city. He said the children and schools appreciate his educational efforts. He pointed out that Mr. Livio had worked with Vice Mayor Adornato's husband to bring the gopher tortoises to the Sand Pine Preserve.
- 5) He stated the importance of voting and wished his fellow commissioners and all candidates running in the election well.

- 6) He commented on Mayor Lonergan's efforts to encourage bicycle riding.
- 7) He stated his appreciation for Commissioner Guevrekian's efforts.
- 8) He recalled great debates with Commissioner Shank and said it had been a pleasure to serve with him.

Mayor Lonergan commented as follows:

- 1) He thanked the residents of Oakland Park for trusting him to serve the city for the past 4 years. He said he had enjoyed working with the commission and staff to improve the quality of life in the City of Oakland Park.
- 2) He thanked the Oakland Park Volunteer Corps members, the Oakland Park Kiwanis Club, the Oakland Park/Wilton Manors Rotary Club, the Oakland Park Business Group, the Broward Sherriff's Office Oakland Park Chief Al Hubrig and his team, Don Widing, Chief of the Fire Rescue Department and his team and City Attorney Doody.
- 3) He was thankful to have served with commissioners who each had his/her own skill set. Even though they did not always agree, their lengthy discussion offered different perspectives. He handed out plaques of appreciation to commission members. Vice Mayor Adornato presented a plaque of appreciation to Mayor Lonergan.
- 4) Later in the meeting, Mayor Lonergan reported that on October 26 he had attended the Mayors' Roundtable with Congresswoman Lois Frankel and Congressman Ted Deutch, who informed him that they could anticipate some sober home legislation in the near future. He had also spoken with Fort Lauderdale Mayor Jack Seiler regarding short-term rental ordinances. Congressman Deutch wished to participate in the Northeast High School tour and the Town Hall meeting. Congressman Deutch had also volunteered to provide a "Congress in the Classroom" presentation.
- 5) He stated Broward County Commissioner Chip LaMarca, a Northeast High School alumni, said he would work with the city on its objectives regarding the school.
- 6) He wished Mr. Livio well in his retirement.
