4 **A RESOLUTION OF THE CITY COMMISSION OF THE CITY**  
5 **OF OAKLAND PARK, FLORIDA, APPROVING THE**  
6 **REPLACEMENT OF THE FIRE RESCUE DEPARTMENT**  
7 **SELF-CONTAINED BREATHING APPARATUS INVENTORY**  
8 **UTILIZING THE MASTER PURCHASE AGREEMENT**  
9 **BETWEEN SOUTH DAVIS METRO FIRE AGENCY AND**  
10 **MUNICIPAL EMERGENCY SERVICES, INC.; PROVIDING**  
11 **FOR CONFLICTS; PROVIDING FOR SEVERABILITY;**  
12 **PROVIDING FOR AN EFFECTIVE DATE.**

14 **WHEREAS,** the City Commission deems it to be in the best interests of the  
15 City to approve the replacement of the Fire Rescue Department Self-Contained  
16 Breathing Apparatus Inventory.

18 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION**  
19 **OF THE CITY OF OAKLAND PARK, FLORIDA THAT:**

21 **SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and  
22 hereby ratified and confirmed by the City Commission. All exhibits attached hereto  
23 are hereby incorporated herein.

25 **SECTION 2.** The City Commission of the City of Oakland Park, Florida,  
26 hereby approves the replacement of the Fire Rescue Department Self-Contained  
27 Breathing Apparatus Inventory utilizing the Master Purchase Agreement between  
28 South Davis Metro Fire Agency and Municipal Emergency Services, Inc.

30 **SECTION 3.** The appropriate City officials are authorized and directed to  
31 execute the necessary documents to comply with this Resolution.  
32

33 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be  
34 and the same are repealed to the extent of such conflict.  
35

36 **SECTION 5.** If any clause, section or other part of this Resolution shall be  
37 held by any court of competent jurisdiction to be unconstitutional or invalid, such  
38 unconstitutional or invalid part shall be considered eliminated and will in no way affect  
39 the validity of the other provisions of this Resolution.

41 **SECTION 6.** This Resolution shall become effective immediately upon its  
42 passage and adoption.
