Please tell us a little about yourself:

For more than twenty-five years I have served my country in any way that I can, first as a member of the U.S. Armed Forces and later through my work as a government official in both appointed and elected positions. As a combat-disabled veteran, I place great importance in looking out for our community at large, including our veterans and individuals living with disabilities.

In 1989, I joined the U.S. Army, where I served in combat and non-combat roles. After being deployed during the Gulf War and earning numerous awards, including an Army Commendation Medal, Army Achievement Medal, and a Southwest Asia Service Medal, I returned to my hometown of Concord, North Carolina, where I devoted my time to working in local government.

In North Carolina, I held appointed positions in several governmental entities, including the Education, Transportation, Health Services, Economic Development, and Small Business commissions and/or committees for Cabarrus County, as well as the U.S. Small Business Advisory Council under House speaker Newt Gingrich. In November of 2000, I was elected to the Cabarrus County Soil and Water Conservation District, becoming the first openly gay Republican elected to a government position in North Carolina.

My involvement in government continued after moving to South Florida, where I was appointed to the board of Parks and Recreation and the Board of Adjustment for the City of Wilton Manors. I have also served as an elected and/or appointed official on the Broward Republican Executive Committee and currently serve on the Broward Democrat Executive Committee as a Precinct Committeeman.

Following the presidential election of 2012, I spoke with the local chairpersons of both the Republican and Democratic Executive Committees, and with their mutual support I made the decision to leave the Republican Party due to its staunchly anti-LGBT policies, which had made me increasingly frustrated and concerned. I married my husband in July of 2013.

I am now a proud Democrat committed to several issues, including economic development, environmental preservation, and ensuring equal rights for all. I am also an elected board member of the Dolphin Democrats and serve on the advisory board of MediXall, LLC, a company committed to improving healthcare services in South Florida and the country as a whole. I recently acquired a landscaping and design business and have renamed it Herman's Landscaping and Design, LLC.

I have lived in Oakland Park for about three years and am proud to call it home.

What fun fact would you like others to know about you?

In the mid-80s I obtained my pilot's license and commercial driver's license. I'm also a member of the ACLU, NRA, Rotary Club of Wilton Manors and Oakland Park, VFW, DAV, and American Legion.
