#### 3. Presentation by Susan Gillis on Centennial History

Ms. Susan Gillis gave a presentation on the Centennial History of Oakland Park.

Member Williams stated that he has a neighbor that has lived in Oakland Park for a long time and she would be a good source to provide additional information on Oakland Park history.

Ms. Gillis explained that a videographer could visit Mr. Williams' neighbor's property to share the video and brochure. She added that she could also conduct an interview over the phone.

Chair Pensabene inquired if the information could be posted to various social media platforms to share with the community as well as include the information in the local newsletter of his Homeowners Association.

Ms. Gillis concurred and stated that the goal is to share Oakland Park history with the neighborhoods in the City.

Member Edwards thanked Ms. Gillis for including a newspaper photograph of a school in Harlem McBride. She stated that she gave the original photograph to the newspaper when it was published. She added that she encouraged her neighborhood to get involved by providing old pictures for the project.

Chair Pensabene suggested that Member Edwards provide Ms. Gillis with a scan of the original photograph so that she could have a picture with a clearer image. Ms. Edwards stated that she would try to get a copy of the original photograph.

Member Williams asked about the time frame for collecting information and photographs related to Oakland Park history and Ms. Gillis stated she was going to take a year to conduct basic research, but the team has almost a decade on the project. She added that the time frame may be extended to allow for additional community input.

In addition, Member Williams inquired about the quality of the photographs should he find pictures of Oakland Park history. Ms. Gillis explained that archival quality standard photographs

would be needed and that she could provide the specific criteria for the photographs to be utilized for the repository.
