30	(G) Park impact fee.
31	(1) If required by the city, residential development shall be subject to payment of a park
32 33	impact fee at the time of building permit issuance for any new residential dwelling unit. A park impact fee shall be paid in the amount of one thousand five hundred (\$1,500.00)
34	per new unit. The park impact fee amount required shall be adjusted as shown below:
35	(a) Effective 10/01/2021: \$1,687.50

36	(b) Effective 10/01/2022: \$1,875.00

37	(c) Effective 10/01/2023: \$2,062.50
38	(d) Effective 10/01/2024: \$2,250.00
39 40	(2) When requiring the park impact fee in lieu of land dedication, a \$1,500.00 payment shall be required prior to issuance of a permit for each new unit.
41	(a) Example: 5 dwelling units $\times$ \$1,500 = \$7,500 fee in lieu of land dedication.
42 43 44 45 46	(b) Fees collected shall be kept in an appropriate park impact fee account for the purpose of park land acquisition, development, enhancement or expansion of existing city owned parks or sites that the city maintains for recreational purposes. The expenditure of these funds shall accommodate increased utilization at the city owned or maintained parks or sites.

49 50 51 52	(B) Park and open space charge. AAs established in Sec. 24-175(G), a park and open space charge of one thousand five hundred dollars (\$1,500.00) for every dwelling unit shall be paid before issuance of a building permit for development and redevelopment within the Downtown Mixed Use District.

If any clause, section or other part of this Ordinance shall be held by any Court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way affecting the validity of the other provisions of this Ordinance.

59 60	<b>SECTION 4.</b> All Ordinances or parts of Ordinances in conflict herewith are hereby repealed to the extent of such conflicts.

It is the intention of the City Commission of the City of Oakland Park, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Oakland Park, Florida, and the Sections of this ordinance may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section," "Article," or such other word or phrase in order to accomplish such intention.
