The regular meeting of the City Commission of the City of Oakland Park, Florida was called to order at 6:30 p.m. by Mayor Bolin.

PRESENTATIONS

* State of the City Address - Mayor Jane Bolin

Mayor Bolin highlighted the accomplishments over the past year including efforts to support staff and the community during the Coronavirus pandemic: the City was the first to open a vaccine pod in Broward County providing 8,000 vaccines and later re-opened in to provide 1,500 booster shots; operated a free food working with Fort Lauderdale and Wilton Manors to operate a free food distribution site that served more than 43,000 people. City staff and volunteers worked with Feeding South Florida to deliver more than 4,000 meals to homebound Oakland Park residents; judicious budget management enabled a reduction of the millage rate the 7th time in 8 years and adopted the lowest millage rate in 11 years; absorbed the 3% credit card fee for utility billing customers, offered financial aid for youth sports and child care, reduced senior rates for wellness programs and implemented a fire assessment exemption helping 600 low income homeowners save more than \$250 on their tax bill; used Cares Act funding to launch small business assistant grant program and awarded almost half a million dollars in grants to local businesses; hosted webinars about loan and grant programs and shared best practices; continued the Find it in Oakland Park campaign; raised more than \$10,000 for the Parade of Orchids at the Stunson Nature Trail as a tribute to the sacrifices made by first responders, healthcare workers, and others; In June we broke ground on phase 1 of City Park, a 5.9 million dollar investment to build amenities that will include a playground, a splash pad, basketball courts and renovated pickle-ball courts; phase 2 will include a 9 acre multi-use complex that will include a new city library, community center, urban forest, butterfly garden and jogging trail; construction contracts were awarded for Fire Station 9 and North Andrews Gardens Community Center which includes a multipurpose facility with public meeting space, playground and basketball courts; the City received 12 responses for a request for qualifications to develop six acres of the city's downtown property to stimulate the economy, increase mobility and shape the future of the community; new OP3D guidelines were adopted to attract quality development and business; in August, Oakland Park was recommended as a location for a potential stop for the commuter rail line, pursued past 10 years and endorsed by 79% of the residents via citywide survey; quality small businesses are coming into the community in record numbers; completed

roadway projects on NW 21 Avenue, Powerline Road and Prospect Road have increased multimodal access; completed projects to modernize water and sewer infrastructure; installed new sidewalks; adopted an affordable housing policy; received grant from Florida Department of Economic Opportunity to conduct 2nd phase of study and develop a successful housing program; celebrated our diversity by unveiling inclusion signs in key locations throughout the city; launched a new city website and increased on-line services; taking steps to protect our community from climate change; working with the Alliance for the National Community Reliance as a pilot community to recover from any emergency; updating storm water master plan to be less vulnerable to flooding; reviewing code to incorporate measures to increase reliance and sustainability; worked with developers to incorporate green space that will add 23 acres of public open space; given away 3,000 trees in the past 5 years with additional funding provided in future years. She thanked the entire community for their bravery, generosity and compassion during this time. Commission members lauded Mayor Bolin for her service and accomplishments.

* Stormwater Presentation

Albert Carbon, Public Works Director, reviewed the November 2020 ETA presentation; stormwater master plan; October 2021 rains; climate change, and the June 2021 stormwater presentation. He noted the six 2020 highlighted located areas of flooding were:

- NW 39th Street, NW 44th Street and NW 20th Terrace
- Royal Palm Lakes and Park Lane West (NW 38th Street)
- North Andrews Gardens Neighborhood
- NE 56th Street near Northeast High School
- NE 38th Street and Coral Lakes
- NE 6th Ave

He addressed the city's elevations; citywide stormwater planning and master plan update; new Broward County and FEMA flood maps and storm surge map; and Broward County funded countywide Risk Assessment/Resilience Plan. He reviewed National Oceanic and Atmospheric Administration (NOAA) 2021, rainfall intensity. Mr. Carbon stated the recent rains measured in Oakland Park between October 22 through October 24 were 1.5 inches with a peak to 2.7 inches. He illustrated the rainfall effect on the city's stormwater system with a video. He reviewed the Stormwater Master Plan updates and FY 2022 Capital Improvements Projects area map.

He continued that the City was working with the County as a partner in the Climate Compact and would integrate all benefits of the plan to the City's actions on sea level rise and drainage. He stated they were working on the final chapters of the Storm Water Master Plan and anticipated presenting it to the City Commission in early 2022. The Stormwater Master Plan would include partnering with private HOAs to connect the lakes to the C-13 canal.

Mayor Bolin suggested advising HOAs who were formulating their budgets for next year that they would be responsible for drain cleaning.

Andrew Thompson, Director of Financial Services provided staff's presentation and recommended adoption.

4. **PUBLIC COMMENTS**

At this time, any person will be allowed to speak on any matter that pertains to City business for a length of time not to exceed four minutes per person.

- Robert Lynn, 659 W. Oakland Park Blvd., appreciated Mayor Bolin's comments and discussed the impact of Covid on the community. He stated Oakland Grove Village residents strongly oppose the Trulieve marijuana dispensary request and had stated so on the Zoom meeting. He stated there were two businesses of the same type already open.
- Wallis Peterson, 1941 NW 36th Street, stated she also opposed the Trulieve proposal because it did not meet the criteria for a conditional use. She had enjoyed the Strategic Planning meeting and remarked on their progress in making Oakland Park a "drive to" and not a "drive through" community.
- Chris Fischer, 3711 NE 13th Avenue, member of the City's Planning and Zoning Board, president of the Corals of Oakland Park Neighborhood Association [COPNA] and vice president of the Neighborhood Coalition of Oakland Park, thanked Commissioner Gordon for attending their neighborhood meeting the previous week. He questioned the makeup of the Selection and Evaluation Committee for the Downtown RFQ. Residents in the affected area felt they had been excluded from the Committee, as only one resident had been appointed.

- Ian Bachaikov, 98 SE 7th Street, Miami, requested that Item 1, the Trulieve request, be heard at the next Commission meeting. He stated their business did not go into areas that did not allow for medical marijuana dispensaries. He pointed out that the existing building was dilapidated and several businesses had been unable to thrive there. He stated they worked with City staff to beautify the area and there would be security all around the building.
- Stephanie Grutman, Ballard Partners, 401 East Las Olas Boulevard, Fort Lauderdale, Trulieve representative, thanked the Commission and everyone who had participated in this process. She addressed some of the concerns expressed about this business. She stated they looked forward to being part of the City
- Steven Arnst, 1860 NE 40th Court, congratulated the City Clerk's office on the new website. Regarding Item 17, he requested the City clean the mold and mildew off pavers first. He wondered how Tamarac had been able to install a sign on the Prospect Road median and requested the City look into it. He noted there were many French drains on NE 11th Avenue that would continue to flood until they were hooked up to the Dixie Highway outfall. He discussed flooding issues at Royal Palm Park and stated they needed pumps to get the water into the C-13 canal. He thanked Mayor Bolin for her service.
- Astrid Ingrid Dorset, 2829 S. Oakland Forest Drive, thanked Mayor Bolin for her service.
- Jack Doren, 4529 Piners Trail West, thanked Mayor Bolin for her leadership over the past year; He appreciated the community meeting on 21st Avenue and recommended a left turn lane at NW 21st Avenue going north to Prospect Road. He agreed with Mr. Arnst regarding the Tamarac sign.
