All exhibits attached hereto are 22 hereby incorporated herein. 23 24 **SECTION 2.** In accepting the recommendation of City staff, the City 25 Commission of the City of Oakland Park, Florida, hereby approves the piggybacking of the H-GAC contract with Texas Underground Inc. for the purchase of a 400 Gallon Jet 26 27 Trailer for an amount not to exceed \$51,550; a copy of the Contract is attached hereto as 28 Exhibit "A". 29 30 **SECTION 3.** All Resolutions or parts of Resolutions in conflict herewith, be 31 and the same are repealed to the extent of such conflict. 32 33 **SECTION 4.** If any clause, section or other part of this Resolution shall be held 34 by any court of competent jurisdiction to be unconstitutional or invalid, such 35 unconstitutional or invalid part shall be considered eliminated and will in no way affect 36 the validity of the other provisions of this Resolution. 37 38 **SECTION 5.** This Resolution shall become effective immediately upon its 39 passage and adoption. 40 41 42 43
