**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO SUBMIT THE GRANT APPLICATION FOR THE COMPLETE STREETS AND OTHER LOCAL INITIATIVES PROGRAM (CSLIP) FOR THE FUNDING OF THE NE 13TH AVENUE IMPROVEMENTS PROJECT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City Commission deems it to be in the best interests of the City to approve and authorize the proper city officials to submit the Grant applications for the Complete Streets and other Local Initiatives Program (CSLIP) for the funding of the NE 13<sup>th</sup> Avenue Project;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA THAT:**

**SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission. All exhibits attached hereto are hereby incorporated herein.

**SECTION 2.** The City Commission of the City of Oakland Park, Florida, hereby approves and authorizes the proper city officials to submit the Grant application and receive funding from the Complete Streets and other Local Initiatives Program (CSLIP) for the funding of the NE 13<sup>th</sup> Avenue Improvement Project.

**SECTION 3.** The City endorses the Florida Department of Transportation (FDOT) delivering the project on the City's behalf, fully administering the design and construction phases of the project.

**SECTION 4.** The City will be responsible to maintain or coordinate the maintenance of the roadways after the project's completion.

**SECTION 5.** The appropriate City officials are authorized and directed to execute the necessary documents to comply with this Resolution.


**SECTION 6.** All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

**SECTION 7.** If any clause, section or other part of this Resolution shall be

46 held by any court of competent jurisdiction to be unconstitutional or invalid, such  
47 unconstitutional or invalid part shall be considered eliminated and will in no way affect the  
48 validity of the other provisions of this Resolution.
