RESOLUTION NO. R-2018-XXX

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, EXPRESSING ITS SUPPORT FOR THE NE 13TH AVENUE PROJECT BEING PROGRAMMED BY THE BROWARD MPO AS EITHER A COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES PROGRAM (CSLIP) OR AS A LOCAL AGENCY PROGRAM (LAP); PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Oakland Park submitted a Complete Streets and other Localized Initiatives Program (CSLIP) grant application to the Broward MPO for the 13th Avenue Improvement Project, and

WHEREAS, the City of Oakland Park is working with the Broward Metropolitan Planning Organization (MPO) to program the project for funding as either a CSLIP project or Local Agency Funded Project; and

WHEREAS, it is the responsibility of the City of Oakland Park to maintain or coordinate the maintenance of the City owned roadways after the project 's completion.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA THAT:

SECTION 1. The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission. All exhibits attached hereto are hereby incorporated herein.

SECTION 2. The City Commission of the City of Oakland Park, Florida, hereby expresses support for the NE 13th Avenue Improvement Project being programmed by the Broward MPO as either a Complete Streets and other Localized Initiatives Program (CSLIP) or under the Local Agency Program (LAP).

SECTION 3. The appropriate City officials are authorized and directed to execute the necessary documents to comply with this Resolution.

SECTION 4. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

SECTION 5. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered eliminated and will in no way affect the validity of the other provisions of this Resolution.
