All exhibits attached hereto are hereby 25 incorporated herein. 26 27 **SECTION 2.** The City Commission of the City of Oakland Park, Florida, hereby 28 approves and authorizes the appropriate city officials to execute the Interlocal Agreement 29 between Broward County and The City for Optional County Services for Keep Broward 30 Beautiful, Household Hazardous Waste and Electronics, and Bulk Trash and Yard Waste 31 Drop-Off Programs. A copy of the Interlocal Agreement is attached hereto as Exhibit 32 "A". 33 34 **SECTION 3.** The appropriate City officials are authorized and directed to 35 execute the necessary documents to comply with this Resolution. 36 37 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and 38 the same are repealed to the extent of such conflict. 39 40 **SECTION 5.** If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such 41
