4 **A RESOLUTION OF THE CITY COMMISSION OF THE**
5 **CITY OF OAKLAND PARK, FLORIDA, APPROVING AND**
6 **AUTHORIZING THE PROPER CITY OFFICIALS TO**
7 **SUBMIT THE GRANT APPLICATION TO THE FLORIDA**
8 **DEPARTMENT OF STATE PUBLIC LIBRARY**
9 **CONSTRUCTION PROGRAM REQUESTING \$500,000 FOR**
10 **THE CITY OF OAKLAND PARK PUBLIC LIBRARY**
11 **PROJECT AND FURTHER AUTHORIZING AN AMOUNT**
12 **OF \$500,000 AS THE CITY'S REQUIRED MATCHING**
13 **FUNDS; PROVIDING FOR CONFLICTS; PROVIDING FOR**
14 **SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

17 WHEREAS, the City of Oakland Park has the opportunity to apply for funding in
18 the amount of \$500,000 for the Public Library Project, with the stipulation of a 1 to 1 matching
19 funds; and

21 WHEREAS, funding in the amount of \$500,000 necessary for the required match, will be
22 available upon award of the grant funding and construction of the project.

24 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY**
25 **OF OAKLAND PARK, FLORIDA THAT:**

27 **SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and hereby
28 ratified and confirmed by the City Commission. All exhibits attached hereto are hereby
29 incorporated herein.

31 **SECTION 2.** The City Commission of the City of Oakland Park, Florida, hereby
32 approves and authorizes the City Manager to submit the Grant application and receive funding
33 from the Public Library Construction Grant for the funding of the Public Library Project.

35 **SECTION 3.** Funding is sufficient and will be available in order that the project will
36 result in a completed library building.
37

38 **SECTION 4.** Sufficient funds will be available to operate the facility upon
39 completion of the project
40

41 **SECTION 5.** The appropriate City officials are authorized and directed to execute the
42 necessary documents to comply with this Resolution.
43

44 **SECTION 6.** All Resolutions or parts of Resolutions in conflict herewith, be and the
45 same are repealed to the extent of such conflict.

47 **SECTION 7.** If funding is awarded the project will be used exclusively for the public

library purposes for which constructed or altered and submit proposed changes in use to the Division for approval if within 20 years of the completion of the construction project.

SECTION 8. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered eliminated and will in no way affect the validity of the other provisions of this Resolution.

SECTION 9. This Resolution shall become effective immediately upon its passage and adoption.
