WHEREAS, the City Commission deems it appropriate and in the best interests of the residents of Oakland Park to amend provisions of Chapter 2 of the Code of Ordinances by specifically amending Section 2-71 entitled “School Advisory Board” to provide for one (1) alternate member;

SECTION 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and is hereby made a specific part of this Ordinance.

Sec. 2-71. - School advisory board.

1 located in the city. No member shall be an employee of the Broward County School
2 Board. All appointments shall be subject to ratification by the city commission. Each
3 member shall serve for a term of one (1) year and the city commission shall appoint
4 new members at the first city commission meeting held in the month of August for
5 each year. Attendance policy for members of this board is governed by section 2-72
6 of this Code of Ordinances.

7 (c) The board shall meet no less than every other month and shall make its
8 recommendations to the city commission to assist the commission in gaining an
9 understanding of the goals and objectives adopted by the Broward County School
10 Board from time to time which would affect the operation and management of the
11 five (5) public schools located within the city.

13 **SECTION 3.** If any clause, section or other part of this Ordinance shall be held
14 by any Court of competent jurisdiction to be unconstitutional or invalid, such
15 unconstitutional or invalid part shall be considered as eliminated and in no way affecting
16 the validity of the other provisions of this Ordinance.

17
18 **SECTION 4.** All Ordinances or parts of Ordinances in conflict herewith are
19 hereby repealed to the extent of such conflicts.

20
21 **SECTION 5.** It is the intention of the City Commission of the City of Oakland
22 Park, that the provisions of this Ordinance shall become and be made a part of the Code
23 of Ordinances of the City of Oakland Park, Florida, and the Sections of this ordinance
24 may be renumbered, re-lettered and the word "Ordinance" may be changed to "Section,"
25 "Article," or such other word or phrase in order to accomplish such intention.

27 **SECTION 6.** This Ordinance shall be effective upon its passage and adoption by
28 the City Commission of the City of Oakland Park.
