14	WHEREAS, the City Commission deems it appropriate and in the best interests
15	of the residents of Oakland Park to amend provisions in Chapter 13 of the Code of
16	Ordinances specifically Section 13-8 entitled "Placement for collection and removal after
17	collection" to provide for hours and placement and removal.
18	
19	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION
20	OF THE CITY OF OAKLAND PARK, FLORIDA, THAT:
21	
22	SECTION 1. The foregoing "Whereas" clauses are hereby ratified and
23	confirmed as being true and correct and are hereby made a part of the Ordinance.
24	SECTION 2. Section 13-8 of the Code of Ordinances entitled "Placement for
25	collection and removal after collection" is amended as follows:
26	
27	(a) All solid waste carts and recycling containers to be emptied by the public works
28	department or private hauler shall be placed at the locations designated by the
29	city before 7:00 a.m., and no earlier than twenty-four (24) hours prior to the
30	next scheduled pick-up and shall be removed no later than 11:00 p.m. on the
31 32	collection days designated by the department. Solid waste carts and recycling
52	containers may be placed in public rights-of-way for collection in a manner

which does not impede the safe flow of vehicular or pedestrian traffic. All solid

waste carts and recycling containers, if visible from the right-of-way, shall be

stored behind the front, or side of the building provided service, where lot

conditions allow for such storage. Containers which are not removed from the

1 2 3 4 5 6 7 8 9	collection locations by the time allowed in this section are subject to removal and proper placement by the service provider and/or subject to Section (c) below. The customer will be charged for the service provider's removal service. A service fee, on file in the city clerk's office, for each such removal service provided by the service provider shall be assessed against the owner or occupant of the property and shall be collected in the manner provided by Section 13-11.5. The fee shall be supplemental to any other penalties provided for violation of this section.		
10 11 12 13 14	(b) Special solid waste collections or services may be arranged with the public works department whereby solid waste will be collected from locations at variance with this section. The type of special collections, services and charges are subject to approval by the director.		
15 16 17 18	(c) Enforcement. Violations of the provisions of the Code of Ordinances shall be enforced in accordance with the provisions of Chapter 24 Article XVII Section 234 of the Code of Ordinances, and through fines in accordance with ordinances and resolutions adopted by the City Commission.		
19	SECTION 3. If any clause, section or other part of the Ordinance shall be held		
20	y Court of competent jurisdiction to be unconstitutional or invalid, such		
21	onstitutional or invalid part shall be considered as eliminated and in no way affecting		
22	the validity of the other provisions of this Ordinance.		
23	SECTION 4. All Ordinances or parts of Ordinances in conflict herewith are		
24	hereby repealed to the extent of such conflicts.		
25	SECTION 5. This Ordinance shall be effective upon its passage and adoption by		
26	the City Commission of the City of Oakland Park.
