3. <u>A public hearing before the Oakland Park Planning and Zoning Board to consider an</u> <u>application by RaceTrac Petroleum, Inc., requesting adoption of an Ordinance to</u> <u>amend the previously granted Conditional Use Approval for a Vehicle Fueling Station</u> <u>with a Convenience Store located at 2351 W Oakland Park Boulevard in the B-1,</u> <u>Community Business Zoning District. Case # CD19-17CU "RaceTrac Petroleum.</u>

Mr. Schwarz provided the staff report. He said the applicant had been granted a conditional use on July 21, 2004, but now wanted exemption from condition #5, which prohibited the sale, use or consumption of alcoholic beverages in single-use containers.

Debbie Orshefsky, attorney for RaceTrac, provided a history of the original application. She stated this was the only existing facility of this type in the city with this condition. When WaWa was approved to sell alcoholic beverages in single-use containers, this became a fairness issue.

Public Hearing - no speakers

Mr. Schwarz confirmed that staff could find no other facilities like this with this restriction.

Mr. Lawrence referred to the Sheriff's report, which stated that rescinding this condition would have an impact on the surrounding community. Mr. Ostroff said he would ask the Chief to reconsider this, since this was the only facility with this prohibition.

Vice Chair Stevens moved to amend the previously granted conditional use ordinance to remove condition #5. Board Member Waters seconded the motion, which prevailed by the following vote: **YES:** Board Member Waters, Vice Chair Stevens, Board Member Lawrence, Chair Doren
