A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA APPOINTING THREE (3) MEMBERS TO SERVE ON THE UNSAFE STRUCTURES BOARD; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Oakland Park appoints nine (9) members of the Unsafe Structures Board Appointment pursuant to Article III of Section 5-31 of the Oakland Park Code of Ordinances; and

WHEREAS, all appointments shall be for the term of three (3) years provided that the term shall continue until a successor is appointed and qualified; and

WHEREAS, the City Commission deems it to be in the best interests of the City to appoint three (3) members to serve on the Unsafe Structures Board;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA THAT:

SECTION 1. The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission.

SECTION 2. The City Commission of the City of Oakland Park, Florida hereby appoints the following three (3) members to serve on the Unsafe Structures Board:
