ORDINANCE NO. O-2020-XXX

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, AMENDING THE CITY’S COMPREHENSIVE PLAN TO PROVIDE FOR THE STATE MANDATED 2020 UPDATES TO THE 10-YEAR WATER SUPPLY FACILITIES WORK PLAN AND BY SPECIFICALLY HOLDING A PUBLIC HEARING TO CONSIDER AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, AMENDING THE CITY’S COMPREHENSIVE PLAN TO PROVIDE FOR THE STATE MANDATED UPDATES TO THE WATER SUPPLY FACILITIES PLAN AND BY SPECIFICALLY AMENDING SECTION 1 “FUTURE LAND USE ELEMENT”; SECTION 4 “INFRASTRUCTURE ELEMENT”; SECTION 5 “COASTAL ELEMENT”; SECTION 6 “CONSERVATION ELEMENT”; SECTION 8 “INTERGOVERNMENTAL COORDINATION”; AND SECTION 9 “CAPITAL IMPROVEMENTS ELEMENT”; AND BY PROVIDING FOR TRANSMITTAL OF THE AMENDMENT, TO THE STATE AGENCIES REQUIRED UNDER CHAPTER 163, PART II, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Community and Economic Development Department of the City recommends that the City Commission amend the Comprehensive Plan to provide for the State mandated 2020 updates to the 10-Year Water Supply Plan and by specifically amending Section 1 “Future Land Use Element”; Section 4 “Infrastructure Element”; Section 5 “Coastal Element”; Section 6 “Conservation Element”; Section 8 “Intergovernmental Coordination Element”; and Section 9 “Capital Improvements Element”; and

WHEREAS, public hearings were held by the City of Oakland Park Local Planning Agency (“LPA”) and Planning & Zoning Board to allow for public participation in relation to the preparation and review of the proposed updates and amendments to the 2007 Comprehensive Plan; and

WHEREAS, the City Commission of the City of Oakland Park, Florida, held a public hearing pursuant to Chapter 163 of the Florida Statutes, at which time the parties

1 and interests and all other citizens and residents of Oakland Park so desiring to participate
2 had an opportunity to be and were heard; and

4 **WHEREAS**, the City Commission of the City of Oakland Park, Florida has
5 determined that the public has adequately participated in the planning process as required
6 by Chapter 163 of the Florida Statutes during the course of the preparation and desires
7 that the amendment be transmitted to the Florida Department of Economic Opportunity
8 “DEO”; and
9

10 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION**
11 **OF THE CITY OF OAKLAND PARK, FLORIDA, THAT:**
12

13 **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and
14 confirmed as being true and correct and are hereby made a part of this Ordinance.
15

16 **SECTION 2.** The City Commission of the City of Oakland Park, Florida hereby
17 approves and adopts the proposed amendments to the City’s Comprehensive Plan that
18 provides for the State mandated 2020 updates to the 10-Year Water Supply Facilities
19 Plan by amending Section 1 “Future Land Use Element”; Section 4 “Infrastructure
20 Element”; Section 5 “Coastal Element”; Section 6 “Conservation Element”; Section 8
21 “Intergovernmental Coordination Element”; and Section 9 “Capital Improvements
22 Element”; The proposed text is attached hereto and identified as exhibit “A”.
23

24 **SECTION 3.** The City Clerk is further directed to transmit a certified copy of
25 this Ordinance to the Florida Department of Economic Opportunity “DEO” pursuant to
26 Chapter 163, Florida Statutes, as well as any other interested governmental entity
27

28 **SECTION 4.** If any clause, section or other part of this Ordinance shall be held
29 by any Court of competent jurisdiction to be unconstitutional or invalid, such
30 unconstitutional or invalid part shall be considered as eliminated and in no way affecting
31 the validity of the other provisions of this Ordinance.
32

33 **SECTION 5.** All Ordinances or parts of Ordinances in conflict herewith are
34 hereby repealed to the extent of such conflicts.
35

36 **SECTION 6.** This Ordinance shall be effective upon its passage and adoption by
37 the City Commission of the City of Oakland Park, Florida,
