11 **CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING**

15 **WHEREAS**, the City Commission deems it to be in the best interests of the City
16 to approve and authorize the proper city officials to execute the proposal from R. Miller
17 Consulting Group to administer the City's Small Business Assistance Grant Program as
18 a part of the Federal Government's CARES Act Funding.

20 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION**
21 **OF THE CITY OF OAKLAND PARK, FLORIDA THAT:**

23 **SECTION 1.** The foregoing "WHEREAS" clause is true and correct and hereby
24 ratified and confirmed by the City Commission. All exhibits attached hereto are hereby
25 incorporated herein.

27 **SECTION 2.** The City Commission of the City of Oakland Park, Florida,
28 hereby approves and authorizes the proper city officials to execute the proposal from R.
29 Miller Consulting Group to administer the City's Small Business Assistance Grant
30 Program as a part of the Federal Government's CARES Act Funding. A copy of the R.
31 Miller Consulting Group Proposal is attached hereto as Exhibit "A".

33 **SECTION 3.** The City Commission of the City of Oakland Park, Florida,
34 hereby authorizes the City Manager to operate the Small Business Assistance
35 Programming, including the authority to make payments to qualified, approved
36 applicants.

38 **SECTION 4.** The City Commission of the City of Oakland Park, Florida hereby
39 approves the Proposed Budget Amendment attached hereto as Exhibit "B".

41 **SECTION 5.** The appropriate City officials are authorized and directed to
42 execute the necessary documents to comply with this Resolution.

SECTION 6. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

SECTION 7. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered eliminated and will in no way affect the validity of the other provisions of this Resolution.

SECTION 8. This Resolution shall become effective immediately upon its passage and adoption.
