22	accepts the recommendation of staff and approves a 3% base wage increase for civil			
23	service and non-classified employees who are not topped out for FY 2020 to be			
24	retroactive to the first full pay period of October 2019 and a 3% base wage increase for			
25	FY 2021 to be effective the first full pay period of October 2020.

27	SECTION 3. The appropriate City officials are authorized and directed to			
28	execute the necessary documents to comply with this Resolution.

30	SECTION 4. All Resolutions or parts of Resolutions in conflict herewith, be and			
31	the same are repealed to the extent of such conflict.

33	SECTION 5. If any clause, section or other part of this Resolution shall be held			
34	by any court of competent jurisdiction to be unconstitutional or invalid, such			
35	unconstitutional or invalid part shall be considered eliminated and will in no way affect			
36	the validity of the other provisions of this Resolution.
