**RESOLUTION NO. R-2021-XXX**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, EXTENDING THE USE OF COMMUNICATION MEDIA TECHNOLOGY FOR ATTENDANCE BY ELECTED AND APPOINTED OFFICIALS FOR AN ADDITIONAL SIXTY (60) DAYS PURSUANT TO EXECUTIVE ORDER NUMBER 21-45 AND ESTABLISHING THE NOTICE REQUIREMENTS FOR USE OF COMMUNICATION MEDIA TECHNOLOGY FOR ATTENDANCE BY ELECTED AND APPOINTED OFFICIALS DURING A PUBLIC HEALTH OR OTHER EMERGENCY; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on Friday, February 26, 2021, Gov. Ron DeSantis issued Executive Order Number 21-45 extending for another sixty (60) days the state of emergency for the coronavirus pandemic; and

**WHEREAS**, upon issuance of a State, County, or Local public health or other emergency order or declaration, attendance via communication media technology may be utilized for a period not to exceed sixty (60) days without City Commission authorization to extend beyond the sixty (60) days; and

**WHEREAS**, Public Notice shall meet the requirements of Florida Statute and/or City Ordinance whichever is applicable; however, Meetings that have been publicly noticed, shall require a forty-eight (48) hours public notice for attendance by use communication media technology; and

**WHEREAS**, the City Commission deems it to be in the best interests of the City to establish the notice requirements for use of communication media technology for attendance by Elected and Appointed Officials during a public health or other emergency.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA THAT:**

**SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and hereby ratified and confirmed by the City Commission. All exhibits attached hereto are hereby incorporated herein.

**SECTION 2.** The City Commission of the City of Oakland Park, Florida, hereby extends for an additional sixty (60) days the use of communication media technology for

1 attendance by Elected and Appointed Officials pursuant to Executive Order Number 20-  
2 45 and establishes the notice requirements for use of communication media technology  
3 for attendance by Elected and Appointed Officials during a public health or other  
4 emergency.

6 **SECTION 3.** The appropriate City officials are authorized and directed to execute  
7 the necessary documents to comply with this Resolution.

8  
9 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and  
10 the same are repealed to the extent of such conflict.

11  
12 **SECTION 5.** If any clause, section or other part of this Resolution shall be held  
13 by any court of competent jurisdiction to be unconstitutional or invalid, such  
14 unconstitutional or invalid part shall be considered eliminated and will in no way affect the  
15 validity of the other provisions of this Resolution.

16  
17 **SECTION 6.** This Resolution shall become effective immediately upon its  
18 passage and adoption.
