3 **A RESOLUTION OF THE BOARD OF COMMISSIONERS OF**
4 **THE OAKLAND PARK COMMUNITY REDEVELOPMENT**
5 **AGENCY (CRA), ADOPTING A TENTATIVE BUDGET FOR THE**
6 **FISCAL YEAR OCTOBER 1, 2021 TO SEPTEMBER 30, 2022;**
7 **PROVIDING FOR CONFLICTS; PROVIDING FOR**
8 **SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

10 **WHEREAS**, the Board of Commissioners of the Oakland Park Community
11 Redevelopment Agency (CRA) has prepared a Tentative Budget for the Fiscal Year
12 beginning October 1, 2021 and ending September 30, 2022, in the form attached hereto
13 as Exhibit “A”, and incorporated herein by reference; and

15 **WHEREAS**, the CRA determined that the said Tentative Budget is in the
16 public's interest and it is necessary to implement its goals and objectives.

18 NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF
19 COMMISSIONERS OF THE OAKLAND PARK COMMUNITY
20 REDEVELOPMENT AGENCY THAT:

22 **SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and
23 hereby ratified and confirmed by the Board of Commissioners of the Oakland Park
24 Redevelopment Agency. All exhibits attached hereto are hereby incorporated herein.

26 **SECTION 2.** The Board of Commissioners of the Oakland Park Community
27 Redevelopment Agency (CRA) hereby adopts the Tentative Budget for the Fiscal Year
28 beginning October 1, 2021 and ending September 30, 2022. The proposed budget for
29 the CRA is attached as Exhibit A.

31 **SECTION 3.** The appropriate CRA officials are authorized and directed to
32 execute the necessary documents to comply with this Resolution.

34 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and
35 the same are repealed to the extent of such conflict.

37 **SECTION 5.** If any clause, section or other part of this Resolution shall be held
38 by any court of competent jurisdiction to be unconstitutional or invalid, such
39 unconstitutional or invalid part shall be considered eliminated and will in no way affect
40 the validity of the other provisions of this Resolution.

SECTION 6. This Resolution shall become effective immediately upon its passage and adoption.
