All exhibits attached hereto are hereby 22 incorporated herein. 23 24 **SECTION 2.** In accepting the recommendation of City staff, the City 25 Commission of the City of Oakland Park, Florida, hereby approves and authorizes the 26 proper city officials to enter into an Agreement of Sale and Assignment of Florida 27 Voluntary Cleanup Tax Credits issued to the City of Oakland Park. A sample agreement 28 is attached for reference as Exhibit "A". 29 30 **SECTION 3.** All Resolutions or parts of Resolutions in conflict herewith, be and 31 the same are repealed to the extent of such conflict. 32 33 **SECTION 4.** If any clause, section or other part of this Resolution shall be held 34 by any court of competent jurisdiction to be unconstitutional or invalid, such 35 unconstitutional or invalid part shall be considered eliminated and will in no way affect 36 the validity of the other provisions of this Resolution. 37 38 SECTION 5.
