2 coordinate the maintenance of the roadways after the project's completion;

4           **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF**  
5 **THE CITY OF OAKLAND PARK, FLORIDA THAT:**

7           **SECTION 1.** The foregoing "WHEREAS" clauses are true and correct and  
8 hereby ratified and confirmed by the City Commission. All exhibits attached hereto are  
9 hereby incorporated herein.

11           **SECTION 2.** The City Commission of the City of Oakland Park, Florida, hereby  
12 expresses its support for the submission of the Complete Streets and Other Localized  
13 Initiatives Grant Program for the NE 15th Avenue Sidewalk Connectivity Project and  
14 authorizes the appropriate City staff to design and construct the project should the project  
15 receive MPO funding.  
16

17           **SECTION 3.** The appropriate City officials are authorized and directed to  
18 execute the necessary documents to comply with this Resolution.  
19

20           **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and  
21 the same are repealed to the extent of such conflict.  
22

23           **SECTION 5.** If any clause, section or other part of this Resolution shall be  
24 held by any court of competent jurisdiction to be unconstitutional or invalid, such  
25 unconstitutional or invalid part shall be considered eliminated and will in no way affect  
26 the validity of the other provisions of this Resolution.  
27

28           **SECTION 6.** This Resolution shall become effective immediately upon its  
29 passage and adoption.
