9 ADDITIONAL TWO (2) YEAR TERM IN ACCORDANCE WITH  
10 ARTICLE III OF THE ORIGINAL AGREEMENT DATED JULY 19,  
11 2017; PROVIDING FOR CONFLICTS; PROVIDING FOR  
12 SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

15           **WHEREAS**, the Board of Commissioners of the Oakland Park Community  
16       Redevelopment Agency (CRA) deems it to be in the best interest to approve the renewal  
17       of the agreement for CRA Plan Implementation Consulting and Other Services between

Miller Consulting Group, LLC. for an additional two (2) year term commencing on September 30, 2020 and ending on September 30, 2022 in accordance with Article III of the original agreement dated July 19, 2017.
