From the Desk of Captain Tammy McNeal

During the third quarter of 2021, the BSO Oakland Park District remained focused on our annual goals: Reduce Crime, Ensure Roadway and Railway Safety, Promote Employee Career Development and Career Pathing, and Youth Guidance.

During the third quarter of 2021, the Broward Sheriff's Office Oakland Park District continued to experience crime reductions, compounding successes from previous quarters. Year to date, our City has experienced a Part One Crime reduction of approximately 23% as compared to 2020. This downward trend is being led by reductions in vehicle burglaries, residential burglaries, thefts and robberies.

BSO Deputies have continued to be steadfast with traffic education and enforcement, issuing almost 3,000 citations this quarter. BSO has had ongoing participation in homeowners, business group and community group meetings, in conjunction with other stakeholders from the City and County, to address some of the longer-standing traffic and roadway concerns.


Our District's commitment to employee career development and career pathing is evident in the promotions and selection of staff for specialty units (as noted on page 16). I have no doubt those deputies who were cultivated here in Oakland Park will return to lead the District in the future, just as Melissa Erdelyi, who was assigned to the Oakland Park District from 2000 to 2005 as a deputy/detective, returned to the District this quarter, now serving as a sergeant.

The third quarter of 2021 also marked the start of the 2021/2022 school year, with students retuning to "on campus" learning. They were welcomed back by our School Resource Deputies, who missed the in-person interaction with the students. Although our staff was creative with initiatives to maintain interaction with the youth of Oakland Park throughout the COVID-19 pandemic, nothing can replace the daily face-to-face interaction between the SROs and the students.

As we approach the end of the year, the BSO Oakland Park District has made substantial progress towards fulfilling our 2021 Goals and Objectives. With the ongoing cooperation and involvement of our residents, business owners, City staff and officials, I have little doubt that we will achieve success. Additionally, the Broward Sheriff's Office Oakland Park District staff want to thank the City officials, residents, and business owners for their continued support, and wish you all a safe, healthy and happy holiday season.





Examples of Crimes Against Persons: Assault, Stalking, Homicide, and Sex Offenses



In the 3rd Quarter of 2021, Crimes Against Property had an overall 16.1% decrease, with 317 offenses reported, compared to 378 offenses reported in the 3rd Quarter of 2020.




Burglary/Breaking and Entering

The total number of reported Larceny/Theft offenses decreased 16.9%, from 296 in the 3rd Quarter of 2020, compared to 246 in the 3rd Quarter of 2021.

Notable Events

Multiple-Burglary Business Arrest

Between 7/3/21 and 7/30/21, three warehouse units at the 4200 block of NE 6th Avenue were burglarized. Through investigation, a primary subject was identified as the perpetrator in all three incidents. On 8/5/21, detectives took the subject into custody. A search warrant was conducted on the subject's vehicle, and property stolen during the burglaries was located within. The subject was charged with three counts of Burglary Business and Grand Theft, and transported to the BSO Main Jail.

Multiple-Burglary Conveyance Arrest

On 7/8/21, deputies responded to the 5100 block of NE 1st Terrace in reference to a report of three delayed conveyance burglaries and an auto theft. Soon after the report, the stolen vehicle was located and recovered in the City of Wilton Manors. Deputies recovered latent prints from the vehicles, which were submitted for analysis. On 8/5/21, a positive identification was obtained from the latent prints, and it was discovered that the subject was in the BSO Main Jail on unrelated charges. On 8/16/21, the subject was interviewed and charged with four counts of Burglary Conveyance and one count of Auto Theft.

Multiple-Burglary Conveyance Arrest

Between 7/1/21 and 8/15/21, several Conveyance Burglaries occurred on the East side of Oakland Park. Through investigation, a primary subject was identified. The subject was located in Fort Lauderdale, and taken into custody on 8/18/21. A search warrant was executed on the subject's residence, and several items stolen during the burglaries – including two loaded firearms – were recovered. The subject was interviewed and charged with four counts of Burglary Conveyance, one count of Armed Burglary Conveyance, one count of Possession of Firearm by a Convicted Felon, one count of Grand Theft of Firearm, two counts of Petit Theft, and one count of Violation of Probation. The subject was transported to the BSO Main Jail.

Armed Carjacking Arrest


On 9/13/21, deputies responded to 3339 N Federal Highway in reference to an Armed Carjacking call. The victim advised that three subjects armed with handguns demanded and entered the victim's vehicle, driving away. On 9/15/21, the victim's vehicle was located in Hollywood, occupied by two subjects. The occupants fled in the vehicle, and after a brief pursuit, the subjects were taken into custody in Miami Gardens. Both subjects were transported to BSO Main Jail.

Traffic Crash Analysis

The District utilizes CrimeView Dashboard to analyze all traffic crashes and issued traffic citations. This technology allows the District to evaluate the location, days of week, and times that traffic crashes occur. This same technology allows the District to examine where and when traffic citations are issued to a violator.

The District conducted several traffic-related initiatives during this quarter:

- Weekly analysis of traffic crash hot spots
- Crash reduction
- Deployed Message Boards with educational messages
- Daily traffic enforcement in school zones
- Commercial vehicle traffic enforcement
- Community Outreach



Community Outreach

District deputies have attended the Crisis Intervention course training. CIT certified deputies respond to persons suffering mental health crises. The Crisis Intervention Team deputies work with the mental health system and advocacy groups to ensure persons with mental health issues receive support. A team of CIT District deputies hits the streets weekly to locate those in need of assistance. They assist with services, transportation, food, clothing and entry into substance abuse programs. These deputies educate, encourage and help these persons get off the streets and into a shelter or abuse program.

Employees of the Month

On July 20th 2021, at approximately 4:01 pm, units were dispatched to a shooting with one victim struck at 4903 NE 9th Ave. Upon arrival, deputies found the victim, who had sustained a gunshot wound to the torso. Life-saving measures were performed by deputies on scene, and the victim was transported to Broward Health to undergo emergency surgery. The victim succumbed to his injuries following surgery.

A perimeter was established and search for the killer was underway with the assistance of K-9, TITAN, and SWAT. As witnesses were located and debriefed, Deputy Howard was alerted by a witness and neighborhood dogs to a possible suspect hiding behind a fence in the yard of a local business. Deputy Howard approached the area, causing the subject to flee. Deputy Howard coordinated apprehension efforts with Deputy Poehl over the radio. Deputy Poehl then observed the subject hiding behind the Tire Kingdom wearing black shorts, shirtless, and carrying a backpack. The suspect appeared to be looking for a way to breach the perimeter. Deputy Poehl immediately requested backup and detained the individual until Deputy Howard arrived. The suspect was identified by witnesses as the shooter and individual responsible for the homicide. The suspect made spontaneous statements to Deputy Poehl about the crime, and later gave Detectives a full confession to the murder. A search of the suspect's backpack revealed the shirt described as being worn by the shooter, and the firearm used.

Deputies Howard and Poehl's dedication to service and safety, attention to detail, and keen observation led to locating and apprehending a violent criminal who had taken a human life and was attempting to get away with it. The Broward Sheriff's Office is lucky to have some of the most talented Law Enforcement personnel. For these reasons and more, Deputy Charles Howard and Deputy Karl Poehl are the Oakland Park Employees of the Month for July 2021.

August 2021 – CSA Kyle Rybinski



During July and August 2021, the Oakland Park District Office underwent a series of building improvements that included the installation of a new generator, new hurricane impact windows, and updates to the building elevator system. This multifaceted project caused a disruption to the normal operations of the District offices. Seeing that this project needed a manager, and knowing that the District was short on supervisory coverage, CSA Rybinski went above and beyond what was expected of him, volunteering to monitor the project and act as the liaison between the construction foreman and the Command staff.

In addition to his daily assigned tasks, CSA Rybinski coordinated the construction project, ensuring the impact on the Oakland Park staff was as minimal as possible, and that the work crews had access to the building as needed. He even made on-the-spot corrections when he observed a lack in the quality of work being done. CSA Rybinski took on a difficult challenge without being asked, requiring little to no supervision in ensuring that the construction project was accomplished.

CSA Rybinski is commended on a job well done, and has earned respect and thanks from this Command. His actions demonstrate his selflessness, professionalism, and dedication to duty that reflect greatly on him, the Oakland Park District, the City of Oakland Park, and the Broward County Sheriff's Office. For all of these reasons, CSA Kyle Rybinski is the Oakland Park District Employee of the Month for August 2021.

September 2021 – Deputy Dustin Sisson



On September 8, 2021, Deputy Dustin Sisson, assigned as the School Resource Deputy at Northeast High School, overheard one of the security specialists ask an administrator if the school had received any threats or had any problems that morning. The school administrator replied that there were no known issues. Deputy Sisson took it upon himself to ensure the safety of students and faculty, and verify that there was no active threat.

Deputy Sisson's investigation revealed that on Sunday, September 5th, the Broward County School Board received an email stating, "THE BOMB HAS BEEN PLANTED," by a named 8th grader. When school was back in session on Wednesday, September 8th, the School Board's Area Security Manager saw the email, and contacted the school's security to ask if there were any problems at the school that morning. When the school's security monitor responded that there were no known problems, the manager closed the case without further investigation. Neither the school's administration, the School Resource Officer, School Board Detectives, nor local law enforcement were advised of this threat.

Deputy Sisson further learned that the named alleged bomber did, in fact, attend the Northeast High School campus as an 8th grader in Rickards Middle School. Sisson became aware that the intent of the threat was to scare the school and have it evacuated to get the named student in trouble. The Threat Management Unit and the School Board's Investigative Unit oversaw the investigation based on the seriousness of the threat. The investigation ultimately revealed that the threat was a hoax. Because of Deputy Sisson's attentiveness, a potentially tragic event was adverted, and it has led to changes within the School Board's receiving and reporting procedures, so a failure like this will not occur again.

Deputy Sisson is commended for his dedication to his position as the School Resource Deputy at Northeast High School, and to its students and faculty. He is an asset to the Oakland Park District, the City of Oakland Park, and the Broward County Sheriff's Office. For these reasons, Deputy Dustin Sisson is the Oakland Park District Employee of the Month for September 2021.

Goals & Objectives 2021

REDUCE CRIME

The Oakland Park District will continue to strive to reduce top tier crime to include Burglary Residence, Burglary Business, Robbery and Auto related crimes.

Reducing crime and increasing the sense of security will always remain the primary focus of the Oakland Park District. In 2020, the District saw a decrease in Part One Crimes. The Oakland Park District will focus on these categories to maintain a low level of occurrence and seek reductions. As is always stated, these reductions are not the product of policing alone, but more so achieved through the partnership of police, community, city staff, and elected officials working together here in Oakland Park.

- District resources will be allocated to educate residents and business owners about crime prevention and current trends to achieve the goal of crime reduction.
- Maintain an emphasis on information sharing between the residents and employees of the District.
- Patrol tactics will continue to be evaluated and improved in an effort to increase apprehensions and deterrence.
- Units will continually be monitored for effectiveness and proper resource allocation.
- Maintain the working relationship with Probation and Parole in identifying juveniles who enter and/or complete probation as a way to reduce recidivism. Further expand the partnership with the Juvenile Division of the State Attorney's Office to have an impact on juveniles who reoffend.
- Utilize new technology when and where available to make better cases and present stronger evidence.

ENSURE ROADWAY AND RAILWAY SAFETY

The Oakland Park District will seek to increase the safety of our residents and visitors by addressing safety concerns in regards to our roadways, sidewalks, and rail corridors.

The City of Oakland Park is making great strides towards making the City friendly for pedestrians, bicyclist and drivers. These efforts include sidewalks, bike lanes, improved roadways with larger swales, and greenspace. The City of Oakland Park is also trifurcated by two dual rail corridors that have numerous rail crossings throughout the City. The Oakland Park District will focus on education and enforcement to increase safety for all these transportation modes.

- Coordinate with rail service providers in providing education opportunities and enforcement campaigns.
- Ensure proper signage on City roadways informing drivers of needed information.
- Educate and promote safe driving habits within the City of Oakland Park.
- Specifically task our deputies to provide youths with information on how to stay safe on the roadways of Oakland Park, to include the dangers of driving while texting or drinking.
- Seek positive interactions to foster better communication and improve perceptions of traffic enforcement. It is important to stress to the public the reality, that traffic enforcement is an educational effort as well as enforcement.
- Reduce the number of serious injury traffic crashes within the City.
- Assign resources to increase enforcement and promote safety.
- Seek additional funding where available to support this initiative.

PROMOTE EMPLOYEE DEVELOPMENT AND CAREER PATHING

The Oakland Park District will participate in advising, guiding, and enacting a global approach to develop the careers of Broward Sheriff's Office employees. The district will evaluate the career desires of the employee as they fit within the goals of the agency.

With the talented and skilled group of employees in the Oakland Park District, it is expected that many will want to grow and advance their career. Additionally, some employees who have spent significant time in Oakland Park have become dependable and reliable resources. When those employees move on to other opportunities, it leaves a void that will need to be seamlessly filled.

- Looking to empower its employees, the District will utilize formal and informal training to assist employees with creating personal career development paths.
- Through the employee performance evaluation process, supervisors will identify employee strengths and potential training opportunities.
- The District will make tangible and intangible resources available to its employees, specifically enhancing career development.
- The District will offer a voluntary survey, as an instrument to help establish a focus on retention of key employees and advancement of those desiring promotion.
- The District will use the above tools and processes to design personalized succession plans, in anticipation of employee movement and/or retirement.

YOUTH GUIDANCE

The Oakland Park District will continue to build and improve a multi-prong effort to curtail youth crime and provide opportunities for growth and foster positive interactions with the youth of Oakland Park.

- Resources will be dedicated to creating positive circumstances where youth may interact with law enforcement officers in a non-confrontational and collegial manner.
- Create positive interactions with at risk youth within the City of Oakland Park. Leverage programs to reengage youth and serve as a positive example that may be missing in their lives.
- Highlight the Explorer Post program that provides today's youth who may be interested in a career in law enforcement with a comprehensive program of training, competition, service and practical experiences. Character development, physical fitness, good citizenship and patriotism are integral components of the overall program.
- The School Resource Officers and Neighborhood Support Team Deputies are tasked to focus on juvenile
 offenders who are believed to be capable of turning around their criminal behavior and getting back on
 the right track to becoming positive and productive citizens. Partnerships with the Broward County
 School Board, Juvenile Justice, Juvenile SOA, Juvenile Probation, Juvenile Judges and BSO Juvenile
 Services are all fundamentals to ensuring successful compliance and program outcomes.
- District Resources are assigned to monitor those juveniles and adults who have committed multiple
 criminal offenses and due to their past and present criminal behavior have been placed on conditional
 release/probation or house arrest and must be closely monitored to ensure compliance with courtmandated sanctions. If not, it is our belief that they will reoffend. These deputies meet routinely with
 the juveniles and their parents to discuss the juvenile's curfews, conditional release and probation.
 Partnerships with the Juvenile SOA and Juvenile Probation are all fundamentals to ensuring successful
 compliance and program outcomes.
- Embrace diversion programs in lieu of criminal prosecution, when applicable, to dissuade youths from reoffending and being introduced into the criminal justice system
- Closely work together with the City of Oakland Park, Broward County School Board, community leaders and the faith-based community through the numerous public programs, activities and presentations that target youth to improve their quality of life in their neighborhoods, community and schools.
- Summer break from school is an opportunity for the City's youth to enjoy time away from school and spend summer vacation with their families and in the community. Many youths enroll in a summer recreation program with the City's Parks and Leisure Department. Deputies will engage the children attending these summer programs as co-participants in a non-police environment.
