Oral Comments at 3/8/21 Planning and Zoning Board Hearing:

Mr. Schwarz: We do have a number of people signed up to speak as well as some written comments.

Acting Chair Stevens: Good

Mr. Schwarz: ...I know Mr. Lynn was the first one, he's been waiting a while I'm going to turn on his microphone.

Mr. Robert Lynn: Ok. My name is Robert Lynn I live at Oakland Grove Village, a 152-unit senior condo community which is about five buildings from this proposed site. I have lived here since 2004. We, uh, our members are always trying to improve our neighborhood. In the past two years we have spent \$250,000 repainting our four buildings, repaving the parking lot, and improving the landscaping. Unfortunately, we're having increasing...let me try and clear my throat ahem (clears throat). Unfortunately, we're having increasing security problems with stolen bicycles and people from Oakland Park Boulevard wandering through our property. We have installed security cameras throughout the property with mixed results. We do not know how this business would operate. I couldn't find anything on before I wrote this. Um, but I vividly remember the issues across the street from this property when a clinic operated an oxycodine distribution center for years with no controls and parenthetically I called the police over and over and over with no results. It was featured on CBS' 60 Minutes and was a real black eye for our neighborhood. It attracted thousands of people from Kentucky, Tennessee, Virginia- where I'm from- who travelled here just to get drugs. In conclusion, I am opposed to anything that will hurt our neighborhood, increase traffic, and make us less safe. Thank you.

Acting Chair Stevens: Thank you Mr. Lynn. Is there anyone else?

Mr. Schwarz. Uh yes let me see Mr. Ron Burr.

Mr. Ron Burr: Hi. Can you hear me?

Mr. Schwarz: Yes. Please state your name and address.

Mr. Ron Burr: My name is Ron Burr my wife is Jerry Burr. We live at 616 Northwest 30th Court in Wilton Manors. We are the street that runs uh parallel to Oakland Park Boulevard about one block south of Oakland Park Boulevard. First of all, I'd like to thank you for letting us know we're not in Oakland Park but we are a good neighbor in Wilton Manors. So we thank you for letting us know what you were discussing tonight. Um my wife and I are very much opposed to this type of business

in our neighborhood. Uh the last gentleman that just spoke has increased-has said that there's been an increase in crime. We have seen it on our street of people wandering through our neighborhood from Oakland Park. There's a business on Oakland Park Boulevard almost directly across from this business that is trying to open up- I will not name the business- but there is a business there that the police are there all the time because of prostitution and drug activity. We would hope that Oakland Park would not approve this issue. We do not need this type of business in our neighborhood. This is less than a half a mile from our house, in fact we are in the 500-foot radius that you showed on the map. And so if it's not good enough for uh daycare or childcare schools, then it's not good enough for us either. Please do not vote to pass this issue. Thank you very much.

- 1. I also put to you that there are two businesses that sell prostitution within two blocks of 301 Oakland Park Boulevard.
