### DRAFT MINUTES CITY COMMISSION MEETING JANUARY 12, 2022, 6:30 P.M.

The regular meeting of the City Commission of the City of Oakland Park, Florida was called to order at 6:30 p.m. by Mayor Carn.

Due to continued safety concerns measures were in place to promote social distancing. The opportunity of public participation virtually has been provided by email or by calling the City Clerk's office. Public comments received were read into record during that portion of the agenda.

### PLEDGE OF ALLEGIANCE

A moment of silence was followed by the Pledge of Allegiance led by City pioneers and volunteers Dr. and Ms. Emma Black.

### PROCLAMATIONS

Commissioner Sparks moved to publish the proclamation. Vice Mayor Gordon seconded the motion, which prevailed by the following vote:

City Manager Hebert noted Item 1, Case # CD20-25CU – "Trulieve Conditional Use" was being deferred at the request of the applicant. Commissioner Sparks reported he would not be attending the February 16th meeting.

Commissioner Rosenwald moved to approve the amended agenda. Commissioner Sparks seconded the motion, which prevailed by the following vote:

### PRESENTATIONS

\* Alliance for National & Community Resilience (ANCR) Benchmarking Presentation

Albert Carbon, Public Works Director, introduced Ryan Colker, Executive Director of ANCR and Illya Azaroff, architect with +LAB, who provided the presentation.

Mr. Carbon reviewed the background of the city's involvement with ANCR beginning in December 2020. Mr. Colker continued and described the Community Resilience Benchmarks and how they affect the community. Mr. Colker stated ANCR worked with city staff and the community and stated the city has achieved the following Designations, making Oakland Park the second city to receive: Enhanced Building Designation, and Enhanced Housing Designation, and the first city to receive the Enhanced Water Designation benchmark. The different levels of benchmarking are Emerging to Essential to Enhanced to Exceptional. These benchmarks support holistic community planning; communication/differentiation; economic development; grant applications; financing; and community stewardship.

Mr. Colker stated the purpose of ANCR benchmarking process results provide the framework for presenting information to the community and a pathway for more in-depth discussion on priorities and potential actions.

Mr. Carbon continued the presentation and elaborated on the city's three enhanced designations: Water Community Resilience Benchmark (CRB), Housing CRB and Building CRB

Mr. Azaroff concluded the presentation stating Oakland Park should be proud of these benchmarks and reminded everyone that Oakland Park's leadership is being seen all around the state. Since Oakland Park received these benchmarks staff has presented at the Florida Housing Coalition and the Southeast Florida Climate Compact. He recommends Oakland Park move forward with the additional benchmarks which will enhance the community, assist with bond financing, future projects, and planning a resilient future.

City Manager Hebert noted there are several items on tonight's agenda that interface with this exercise. Important to understanding that plans are the foundation, and having an understanding of where are and where we want to head, is what this process is all about.

Commissioner Rosenwald inquired if they should consider the timing of adopting the benchmarks as they relate to the other city plans. City Manager Hebert explained that adopting the update of the Comprehensive Plan, which is on the agenda this evening that process would look holistically at all the elements within the ordinances and codes that dealt with planning. The benchmarks would be used to help attain these goals. This would be an 18-24 month exercise that would take place and engage commissioners, stakeholders, community groups over the next two years to redraft our code provisions and bring the recommendations back and then used as a tool to us on which areas we should be focusing on for improvement to achieve those goals.

Commissioner Rosenwald inquired if there a need to formally adopt benchmarks. City Manager replied that this was a first impression; however, would be happy to formalize in a resolution of support if requested.

Commissioner Sparks thanked the presenters and recognition received as well as staff's efforts.

Vice Mayor Gordon thanked the city manager and staff for their efforts to and forward thinking to connect with ANCR for awarding the city for this accomplishment.

Mayor Carn remarked his was excellent recognition, thanked staff for being responsible and transparent with this effort would like to celebrate and share this good news.

### **<u>\* City Facilities Presentation Update</u>**

Brynt Johnson, Director of Engineering and Construction Management, Sierra Marrero, Assistant Director of Engineering and Building Services and Andrew Thompson, Chief Financial Officer provided staff's presentation.

Mr. Johnson reviewed the general phasing plan timeline consist of three phases.

- Phase I, started in 2019 which includes: Fire Station 9; City Park Phase 1; Fire Station 20 subject to litigation; Fire Station 87 Phase 1; North Andrews Gardens Community Center; Municipal Building Hardening; and Park Place Improvements. This phase will be completed in 2024;
- Phase II started in 2020 which includes: Fire Station 87 Phase II and City Park Phase II. Phase to be completed in 2023
- Phase III will start in 2023 which includes: Park Place at Jaco and Pastorius Park. This phase will be completed 2029.

Mr. Johnson explained the project development through the Construction Manager at Risk (CMAR) process. He noted the Association of General Contractors of America (AGC) issued a construction inflation alert in 2021 outlining: extreme cost increases; supply-chain distributions; continued volatility in material costs; lengthened lead times for both production and delivery.

Mr. Thompson reviewed the current bond estimated deficit of \$21.4 million. He stated the issues that contributed to the deficit were the escalation of material prices, unforeseen conditions of contamination and soil conditions, and FEMA flood elevation changes. Mr. Thompson suggested the following steps in addressing the bond deficit:

- Phase in certain amenities over time (i.e. Phase II boardwalk, landscaping, walkway lighting, etc.)
- Analyze alternative materials and construction methods
- Reduction of scope
- Application of bond premium
- Explore additional Grant opportunities
  - Current pending grant applications total \$24.09 million

Mr. Thompson confirmed the City was aggressively pursuing grant opportunities. Project schedules need to be flexible and adjusted to meet the grant notifications, agreements, deliverables, and timelines. The grant challenges are 1. Timelines: release and approval of grants; cannot spend funding before the grant award; time between the notice of grant awards and actual grant agreement. 2. The grant restrictions on how, where, what, when funding is allocated and spent. The current pending grant applications total \$24.09 million.

The American Rescue Plan Act (ARPA) funds must be encumbered by 12/31/24 and fully spent by 12/31/26. The city is receiving \$22.6 million. The potential use of ARPA monies for projects funding gaps may be applied to Fire Station 9 and Public Works Administration Building. Ms. Marrero updated the status on the following bond projects:

- Municipal Building
  - Scope of Work: hardening of the facility
  - Status: Guaranteed Maximum Price (GMP) awarded; Notice to Proceed (NTP) issued 1/11/2021
  - Construction Cost: \$1.3 million; awarded grants \$546,751

- Estimated completion early 2022
- City Park Phase I
  - Scope of Work: splash pad; playground; pickleball courts; basketball courts; new ADA restrooms; concession building renovation; covered pavilion, and social stairs
  - Status: construction underway
  - Construction Cost: \$5.9 million; awarded grants \$20,000
  - Estimated completion Fall of 2022
- City Park Phase II
  - Status: Schematic design contract awarded; CMAR pre-construction contract awarded
  - Estimated Construction Cost: \$28.03 million; potential pending grant awards \$15.2 million
  - Estimated completion 2029
- City Parks Connected
  - Richard E. Giusti Heart Par Cours Park design underway includes: new dog park; ADA compliant parking; parking lot lighting; exercise trail; and exercise equipment
  - Dr. Carter G. Woodson Park project scoping underway includes: new playground surfacing; basketball court renovations; new community gardens; and upgraded security and lighting
- Fire Station 9
  - Status: 90% design submittal received
  - Estimated Construction Cost: \$11.8 million; potential pending grant funds \$7.9 million
  - Estimated Completion 2025
- North Andrews Gardens
  - Status: 60% design submittal received
  - Estimated Construction Cost: \$4.6 million; awarded grants total \$250,000
- Fire Station 87 Phase I
  - Scope of Work: hardening of facility
  - Status: 100% design submittal received
  - Estimated Construction Cost: \$1.5 million; awarded grants total \$833,744
  - Estimated Completion Phase I 18 months following grant agreement execution.
- Fire Station 87 Phase II
  - Status: Façade design approved
  - Estimate Construction Cost: \$3-\$4 million
  - Estimated Completion 2029
- Fire Station 20
  - Status: Project pending litigation and exploring options for project development.
  - HMGP grant application has been submitted in the amount of \$904,872 for plans and upgrades to the existing station while timelines for the new facility are explored

Ms. Marrero provided an update to other facilities projects:

- New Public Works Facility
  - Status: 90% design submittal received
  - Estimated Construction Cost: \$25.3 million; awarded grants \$1 million
  - Estimated Completion 2025
- Sky Building
  - Status: Spatial planning underway
  - Estimated Cost: \$4-5 Million
  - Estimated Completion 2026
- Park Place Building Remediation
  - Status: Construction completed \$463,422
  - Next Steps: Public Works Operations to occupy Park Place Building
- Park Place Parking Lot
  - Status: GMP awarded
  - Construction Cost: \$498,404; awarded grant total \$347,898
  - Estimated Completion: Spring 2022

Vice Mayor Gordon stated her appreciation for the presentation and keeping the Commission informed on the progress of projects.

Commissioner Rosenwald noted the opportunity for park connectivity, inquired about funding through the ARPA grant, and if bond funding can assist with Station 20 conditions.

City Manager Hebert explained ARPA funding process, timing and obstacles regarding the new Station 20 and commitment for improvements to the current station location.

Commissioner Sparks requested Fire Station 20 not be adaptive response, but rather a full station once moved into the new facility.

### **\*** Community Appearance Presentation

Peter Schwarz, Director of Engineering and Community Development, introduced the presentation which examines current Code related to community appearance for deficiencies; determine if related Code is understandable for staff, community, and BSO counterparts; identify any conflicts; review enforceability; identify objectives standards and conduct a peer review of other municipalities for best practices.

Mr. Schwarz identified the following proposed areas of review: residential parking, commercial vehicles in residential areas; parking for boats and trailers; regulation of business activity in residential areas including private vehicle repair and mobile vehicle repair tradesmen; business equipment storage; landscaping and overgrowth maintenance standards in residential areas; maintenance vacant lots; stronger solid waste and bulk trash regulations; housing appearance, painting and maintenance; fences and walls; accessory structures; use of hurricane shutters; boarding vacant or abandoned properties; tarps, damaged and inadequate roofing; lawn and landscaping affect residential neighborhoods; use of rock and gravel in swales.

Mr. Schwarz concluded the presentation with the following next steps: retain consultant to work with staff to address concerns; review of current Code and best practices; legal review with staff; public input; staff review and recommendation; presentation to City Commission; presentation to Planning & Zoning Board and adopt an Ordinance.

Commissioner Sparks encouraged staff to move quickly before Home Rule was taken away.

Commissioner Rosenwald requested sidewalk maintenance to be reviewed.

Mayor Carn recalled a movement in the City to eliminate the term code enforcement and instead use community enhancement. He mentioned a cultural shift improve efforts to clean up the City. A recent experience at the bus stop left him in disbelief and embarrassed by the debris and poorly maintained swales.

### ORDINANCES ON FIRST READING

2. Supplemental General Obligation Bond Ordinance for Series 2022.

Andrew Thompson, Chief Financial Officer, provided staff presentation recapping that City voters approved the \$40 million general obligation bonds in 2018. The first series of bonds totaled \$26 million and were issued in 2020. The second series is planned to issue in the calendar year of 2022 for the remaining \$14 million. The City Commission approved RBC Capital Market as the underwriter October 20, 2021. The City earned AA credit rating. The Supplemental Ordinance will provide the authority for the sale of bond scheduled for February and will mature February 1, 2042 and will not exceed \$14 million. Interest will be determined when the bond goes to market. Debt service will begin in fiscal year 2023.

The Supplemental General Obligation Bond Ordinance for Series 2022 will return for second reading February 2, 2022.

Commissioner Rosenwald moved to pass the ordinance on first reading. Commissioner Sparks seconded the motion, which prevailed by the following vote:
