89           **Section 3.**     If any clause, section or other part of this Ordinance shall be held  
90 by any Court of competent jurisdiction to be unconstitutional or invalid, such  
91 unconstitutional or invalid part shall be considered as eliminated and in no way  
92 affecting the validity of the other provisions of this Ordinance.

94           **Section 4.**     All Ordinances or parts of Ordinances in conflict herewith are  
95 hereby repealed to the extent of such conflicts.  
96

97           **Section 5.**     It is the intention of the City Commission of the City of Oakland  
98 Park, that the provisions of this Ordinance shall become and be made a part of the Code  
99 of Ordinances of the City of Oakland Park, Florida, and the Sections of this ordinance  
100 may be renumbered, re-lettered and the word "Ordinance" may be changed to  
101 "Section," "Article," or such other word or phrase in order to accomplish such  
102 intention.  
103

104           **Section 6.**     This Ordinance shall be effective upon its passage and adoption  
105 by the City Commission of the City of Oakland Park.
