PRESENTATIONS

* City Facilities Update

Brynt Johnson, Director of Engineering and Building Services and Sierra Marrero, Assistant Director of Engineering and Building Services provided staff's presentation.

Mr. Johnson reviewed the new building renderings, bond implementations goals and budget. The current estimated cost for all projects totals \$67,176,409; creating a budget deficit of \$16,764,175. The major challenges are: escalation of material prices; labor cost escalations; gas and petroleum increases; material shortages/extended lead times; unforeseen conditions — environmental contamination and soil condition; and FEMA flood elevation changes. He stated the next steps would be: phasing the projects; analyze alternative materials/construction methods; delaying projects; public private partnership options; explore additional grant opportunities. Current pending grant applications total \$8,354,690.

City Manager Hebert explained they were considering bifurcating phase 2, the north side of the park, to add the amenities now while they continued to monitor construction costs.

Commissioner Bolin inquired about the order/priorities of projects. City Manager Hebert discussed their prioritization strategy.

Commissioner Rosenwald inquired if there was any deadline for the bond-related projects and City Manager Hebert stated generally no, because they had floated all bond funds.

Mayor Carn suggested philanthropy efforts be explored.

* Hurricane 2022 Update

Fire Chief Krivjanik shared information on special needs shelters and the vulnerable residents list. He encouraged those with Special Needs to call 954-537-2888 to register now.

Mayor Carn inquired about residents who lived alone and Chief Krivjanik stated they distribute a "Vile of Life" at events that residents fill with their critical information and place it in the refrigerator with tag on the door for first responders to find in case of an emergency.

• Carrie Connely, 2825 NE 10th Avenue, Wilton Manors 46 year resident and concerned about: a possible increase in noise levels: environmental issues, specifically the protected mangroves, privacy issues, and a decrease in resale values with potential buildout.

Ms. Pruss confirmed Mangroves would be protected per state law as well as our tidal barrier ordnance proposes language to encourage the preservation of natural features over the establishment of engineered barriers.

- Gloria Weatherington, 1260 NE 38th Street, requested flexibility for parking for existing buildings.
- Katherine Peterson, 1001 NE 28th Drive, Wilton Manors, discussed environmental concerns, specifically regarding maintaining existing trees and native landscaping and preserving the natural riverscape. She was also concerned about the expiration of the affordable housing requirement and recommended the notices be in multiple languages.

• Katherine Peterson, 1001 NE 28th Drive, Wilton Manors, stated concern about the setbacks that would be allowed, noting the five-story building height. She recommended notices be posted in multiple languages. She discussed the 15-year limit for the affordable housing. She invited the commission to come visit the river and noted this was one of the few remaining natural riverbanks on the Middle River and it would break the eco system if it were lost.

City Clerk Shrout read comments that had been submitted into the record:

Dr. Zannins, 1025 NE 25th Drive, Wilton Manors, two doors down from the U-Haul, along with 15 neighbors are very concerned with any disruption to the natural shoreline noting development would threaten this unique space admired by many boaters and kayakers. Many animal species need this environment to thrive. He inquired if an environmental impact study had been conducted.
