- 2. The Inspection Period as defined under Section 1.23 of the Original Agreement is hereby extended up to and including December 20, 2022, after which date the Inspection Period shall expire.
- 3. All other terms and provisions of the Original Agreement not otherwise modified by this First Amendment are hereby ratified and confirmed, and shall remain in full force and effect.
- 4. In the event of any inconsistencies between this First Amendment and the Original Agreement, the provisions contained in this First Amendment shall prevail. In any other respects, the Original Agreement remains unchanged. All capitalized terms used but not defined herein shall have the meaning assigned in the Original Agreement.
