All exhibits attached hereto are hereby 25 incorporated herein. 26 SECTION 2. The City Commission of the City of Oakland Park, Florida, hereby 27 28 approves and authorizes the appropriate City officials to execute a Work Authorization 29 with Zyscovich Architects for architectural and engineering services for the Phase 2 30 Interior Design Development and Construction Document Phase of the City Hall Space 31 within the Sky Building in an amount not to exceed \$83,850. The Work Authorization is 32 attached hereto as Exhibit "A". 33 34 **SECTION 3.** The appropriate City officials are authorized and directed to 35 execute the necessary documents to comply with this Resolution. 36 37 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and 38 the same are repealed to the extent of such conflict. 39 40 **SECTION 5.** If any clause, section or other part of this Resolution shall be held 41 by any court of competent jurisdiction to be unconstitutional or invalid, such 42 unconstitutional or invalid part shall be considered eliminated and will in no way affect

43 the validity of the other provisions of this Resolution.
