The Second Amendment is attached hereto as Exhibit "A". 28 29 SECTION 3. The appropriate City officials are authorized and directed to 30 execute the necessary documents to comply with this Resolution. 31 32 **SECTION 4.** All Resolutions or parts of Resolutions in conflict herewith, be and 33 the same are repealed to the extent of such conflict. 34 35 **SECTION 5.** If any clause, section or other part of this Resolution shall be held 36 by any court of competent jurisdiction to be unconstitutional or invalid, such 37 unconstitutional or invalid part shall be considered eliminated and will in no way affect 38 the validity of the other provisions of this Resolution. 39 40 SECTION 6. This Resolution shall become effective immediately upon its 41 passage and adoption.
