WHEREAS, the City Commission has met and considered the recommendations, 27 the suggested final budget, and the final operating and voted debt service millage rates 28 necessary to be levied to carry on the government of the City and pay for General 29 Obligation Bonds for the ensuing year; 30

SECTION 1. The final budget of the City of Oakland Park, Florida, for the fiscal 35 year beginning October 1, 2023 and ending September 30, 2024, a copy of which is 36 attached hereto and more particularly set forth in Exhibit "A", are hereby adopted and the 37 38 appropriations set out therein are hereby made to maintain and carry on the government of the City of Oakland Park, Florida. 39

SECTION 2. All delinquent taxes collected during the ensuing fiscal year as 41 proceeds from levies of operating millage of prior years are hereby specifically 42 appropriated for the use of the General Fund. 43

SECTION 3. All unexpended Appropriations as of September 30, 2023 for each approved Fiscal Year 2022-2023 Capital Project in each fund is hereby encumbered for that specific Project until its completion. All Encumbered Appropriations remaining after each specific Project is completed shall be appropriated to the respective Funds Unappropriated Fund Balance/Fund Equity. All administratively approved general and other operating funds appropriations as of September 30, 2023 are hereby encumbered until paid.

- 9 SECTION 4. The City Fiscal Policies, a copy of which is attached hereto and
 10 more particularly set forth in Exhibit "B", are hereby adopted.
- 12 **SECTION 5.** The Citywide Compensation Plan, a copy of which is attached 13 hereto and more particularly set forth in Exhibit "C", is hereby adopted.
- SECTION 6. The Capital Improvement Plan, a copy of which is attached hereto
 and more particularly set forth in Exhibit "D", is hereby adopted.

18 **SECTION 7.** If any clause, section or other part of this Resolution shall be held 19 by any court of competent jurisdiction to be unconstitutional or invalid, such 20 unconstitutional or invalid part shall be considered as eliminated and shall in no way 21 affect the validity of the remaining portions of this Resolution.

- 23 **SECTION 8.** All Resolutions or parts of Resolutions in conflict herewith are 24 hereby repealed to the extent of such conflict.
- 26 **SECTION 9.** This Resolution shall become effective upon its passage and 27 adoption.
