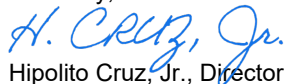
In accordance with the terms of the Interlocal Agreement for Guaranteed Partial Service between the City of Oakland Park and the Broward County Building Code Division, this letter serves to report that, due to the rising inflation in the economy, effective October 1st, 2026, a rate increase in line with your current interlocal agreement will be applied to the following hourly rate structure: Building Official, Chief Building Code Inspector, Plans Examiner and Building Code Inspector. The new rates are listed below. Please note, Clerical Support will not incur a rate increase (0%) and will remain the same for Fiscal Year 2027. Therefore, the following hourly rates have been used to develop the County's budget:

<i>Building Official.....</i>	<i>\$101.30/hour</i>
<i>Chief Building Code Inspector.....</i>	<i>\$101.28/hour</i>
<i>Plans Examiner.....</i>	<i>\$101.27/hour</i>
<i>Code/Building Code Inspector.....</i>	<i>\$101.17/hour</i>
<i>Clerical Support.....</i>	<i>\$39.60/hour</i>

We understand the need to keep hourly rates as low as possible and have implemented all measures to reduce costs. We are still committed to placing our customers' needs first and will work diligently during the development of future budgets to minimize further increases. We hope to keep your trust and build on the solid foundation that has supported our successful partnership over the years.
