A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF OAKLAND PARK, FLORIDA, APPROVING AND AUTHORIZING THE PURCHASE OF PHARMACEUTICAL AND MEDICAL SUPPLIES FROM MEDLINE INDUSTRIES, INC. PIGGYBACKING OMNIA PARTNERS CONTRACT #2021003157 IN AN AMOUNT NOT TO EXCEED THE FUNDING APPROVED IN THE FY 2027 OPERATING BUDGET, SUBJECT TO FINAL BUDGET ADOPTION AND APPROPRIATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission deems it to be in the best interests of the City to approve and authorize the purchase of pharmaceutical and medical supplies from Medline Industries, Inc. piggybacking OMNIA Partners Contract #2021003157 in an amount not to exceed the funding approved in the FY 2027 Operating Budget, subject to final budget adoption and appropriation.

SECTION 3. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

SECTION 4. The appropriate City officials are authorized and directed to execute the necessary documents to comply with this Resolution.

SECTION 5. If any clause, section or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered eliminated and will in no way affect the validity of the other provisions of this Resolution.
